Online Grade Book/Parent Portal MOU

The District and the Association agree to the following:

- Based on current usage and WASC recommendations, High School teachers shall use the Infinite Campus Online Grade Book.
- The District shall support one grade book program, Infinite Campus or Jupiter Grades, at each Middle School. Middle School sites will select one grade book program to be used consistently school wide based upon the site simple majority vote.
- Due to the Standards-Based Report Card, elementary grades (K-5) shall be excluded from this MOU. Elementary teachers will also have access to both online grade book programs. If elementary teachers choose to use Jupiter Grades (paid by the District) all conditions of the MOU shall apply.
- The Jupiter Grades grade book program must continue to be compatible with the District technology system. All maintenance and updating of the system shall be done by Jupiter Grades.
- In order to provide ongoing communication regarding student progress, grade books shall be updated as soon as possible, but at least every two (2) weeks or at the conclusion of a unit of study (not to exceed three weeks).
- Unit members may attend I.C. trainings if needed as determined by the site principal or at the unit member's request. Training outside the regular work day shall be compensated at the extra duty rate.

The Association and District shall review both online grade book programs quarterly. Bargaining unit member feedback shall be provided to the Association and District staff to improve the effectiveness of the grade book programs. If issues arise with either system, unit members shall immediately contact site Association representatives and site administration.

It is the expectation of the District that unit members shall use one of the two online Grade Book programs.

This MOU shall be reviewed by the end of February each year to determine if any changes/modifications are needed for the following year.

This MOU shall expire June 30, 2021.
